\$1.00 to \$500.00 -----\$31.29

\$501.00 to \$2,000.00-----\$31.29 for the first \$500.00 plus \$3.52 for each additional \$100.00 or fraction thereof, to and including \$2,000.00.

\$2,001.00 to \$25,000.00-----\$84.09 for the first \$2,000.00 plus \$16.15 for each additional \$1,000.00 or fraction thereof, to and including\$25,000.00.

\$25,000.00 to \$50,000.00-----\$455.54 for the first \$25,000.00 plus \$11.64 for each additional \$1,000.00 or fraction thereof, to and including \$50,000.00.

\$50,001.00 to \$100,000.00-----\$746.54 for the first \$50,000.00 plus \$8.07 for each additional \$1,000.00 or fraction thereof, to and including \$100,000.00.

\$100,001.00 to \$500,000.00-----\$1,150.04 for the first \$100,000.00 plus \$6.46 for each additional \$1,000.00 or fraction thereof, to and including \$500,000.00.

\$500,001 to \$1,000,000.00-----\$3,734.04 for the first \$500,000.00 plus \$5.47 for each additional \$1,000.00 or fraction thereof, to and including \$1,000,000.00.

\$1,000,001.00 and up-----\$6469.04 for the first \$1,000,000.00 pls \$3.52 for each additional \$1,000.00 or fraction thereof.

*** Plan review for residential construction is equal to one-half of the building permit fee.**

*** Plan review for commercial construction is equal to sixty five percent of the building permit fee.**

*** Continuing education fee is equal to 0.0002 multiplied by the total valuation for any project.**
