Project Description: The Proposed Engine House will be a 40' wide X 75' long structure. The structure will be used to store, maintain, display, and operate Engine 18 and other railroad artifacts. Approximately 130 lineal feet of usable track will be laid inside the Engine House with approximately 1,000 lineal feet of exterior track. Interior improvements: may include a concrete slab, may include work bench and other equipment for maintenance and restoration work, may include bathroom facilities, may include break/meeting room, two track lines, electrical outlets/lighting, etc. Part of the new exterior tracks will be placed in areas designated Open Space & Recreation and zoned Open Spaces. The portion of the Eastern California Museum that is zoned and designated Open Space will be rezoned to Public and re-designated.



Project Location: 115 N Grant Street, Independence, CA. The proposed project is located on the grounds of the Eastern Sierra Museum, to the south of the existing parking lot and museum building on the south end of the parcel.

Brief Project Description: The proposed project involves the construction of a 40' wide x 75' long Engine House. The structure will be used to store, maintain, and display Engine 18 (an operational exhibit) and other railroad artifacts. Approximately 130 lineal feet of useable track will be laid inside the Engine House with approximately 1,000 lineal feet of exterior track. The project will involve zoning reclassification to Public and General Plan re-designation to Public Facilities.

Determination: Based on a review of the project as proposed, the Department of Fish and Wildlife has determined that for purposes of the assessment of CEQA filing fees (Fish and G.
