DRAFT ENVIRONMENTAL IMPACT REPORT FOR THE ATV ADVENTURE TRAILS OF THE EASTERN SIERRA PROJECT** – The Adventure Trails System of the Eastern Sierra, Inc. has submitted an application for a proposed project in accordance with Assembly Bill (AB) 628 and the Inyo County AB 628 Implementing Procedures to undertake a pilot project to designate several combined-use routes up to ten miles long on certain unincorporated County roads; and the City of Bishop to undertake a project to designate several combined-use routes of up to three miles long on certain roads maintained by the City of Bishop. Inyo County has prepared a Draft Environmental Impact Report (DEIR) pursuant to CEQA for implementation of the 38 combined-use routes within County- and City-maintained roads in and around the unincorporated communities of Aberdeen, Big Pine, Independence, Lone Pine; and routes in and around the City of Bishop. The Committee will receive a presentation from the applicant and provide input regarding the DEIR to the Planning Commission and Board of Supervisors.
