6. **OLD BIG PINE LIBRARY BUILDING: INYO COUNTY SALE/DONATION & BIG PINE FIRE DEPARTMENT DEMOLITION (Public Hearing & Action Item)** - Inyo County owns the site and building which housed the former Big Pine library (201 N. Main Street), and now proposes to sell (or donate) the site to the Big Pine Fire Department. As the library building is greater than 50 years old, and was included in the Inyo County Historical Survey, the County prepared a California Environmental Quality Act (CEQA) checklist focusing on the historical aspects of the project, finding that the building did not need to be preserved as a significant historical resource.

The General Plan designation for the property is Central Business District and the zoning is Central Business.
