Please make two separate payments, one payment of \$1,000.00 to Inyo County Planning, and one payment of \$300.00 to Inyo County Board of Supervisors. If you challenge in court any finding, determination or decision made pursuant to a public hearing on a matter contained in this agenda, you may be limited to raising only those issues you or someone else raised at the public hearing, or in written correspondence delivered to the Inyo County Planning Commission at, or prior to, the public hearing.
